Business Training and Advanced Workshops: In fiscal year 2014, Washington CASH provided service to a total of 543 clients. This includes 16 Business Development Training courses for 362 clients, with a graduation rate of 86% and a total of 408 clients received over 1200 hours of one-on-one technical assistance with Washington CASH business consultants. In addition, staff facilitated 18 advanced workshops for 98 business training graduates, with topics ranging from retail skills to computer topics.

4b (Code:) (Expenses \$ 252,760. including grants of \$) (Revenue \$ 174,242.)

Retail Store: In fiscal year 2014, there were 93 CASH business training graduates with products for sale at the Ventures retail incubator. 52 additional clients from outside of the CASH program have products displayed at the store. Ventures generated approximately \$200,000 in revenue for clients in fiscal year 2014.

Financial Services: In fiscal year 2014, Washington CASH loaned out \$60,322 to aspiring entrepreneurs, with an 98% repayment rate. In fiscal year 2014, 28 small business owners opened Individual Development Accounts, with all IDA holders saving over \$123,000 to invest in their businesses through our 2:1 matching program. In addition to these services Washington CASH ran two 16 week Financial Management courses out of which 32 clients graduated.
